## **Instructions to Bidders**

- 1. The bids should be quoted separately and put in different sealed envelopes marked as "Technical Bid" and "Financial Bid" which are to be put in separate envelopes and should be properly sealed along with super-scribed as "TENDER FOR SPORTS ITEMS"
- 2. All tender documents should be submitted directly to the office of the Directorate, Sports & Youth Affairs, Meghalaya.
- 3. Quotation received after the closing date/time will not be considered.
- 4. The quantity shown against the item is tentative and may vary as per dynamic requirement of the office.
- 5. In the event of any dispute or difference(s) between the office and the Vendor(s) arising out of non-supply of material or supplies not found according to specifications or any other cause whatsoever relating to the supply or purchase order before or after the supply has been executed, shall be referred to "The Director, Sports & Youth Affairs who may decide the matter and which shall be final and binding.
- 6. All tenders in which any of the prescribed conditions is not fulfilled or any condition is put forth by the tenderer shall be summarily rejected.
- 7. The quoted price will remain valid for 3 month and no alteration/change in rate is allowed after issue of Work Order/Purchase Order.
- 8. The Bidders must submit the copies of (a) Firm Registration Certificate in case of non-scheduled tribe and obtain, (b) Trade License by the Khasi Hills Autonomous District valid for FY 2022-23 and (c) GST Registration along with bid.
- 9. Quotations may either be on (a) letter head or (b) format but duly stamped by the authorized signatory along with a forwarding letter on letter head. Otherwise the bid shall stand rejected.
- 10. Payment shall be made only after the receiving of materials against the Purchase Order with satisfactory level ensuring all the specification and the quality of the material/items ordered.
- 11. Contact Nos. and E-mail IDs of Authorized persons of the firm must be given.
- 12. Directorate can cancel fully or partially the item based on their requirement or can increase or decrease the quantity. Bidder cannot claim any cost from the office.
- 13. The bidder should not have been blacklisted by any central/state government bodies. Declaration of the same to be enclosed along with tender document.
- 14. The price quoted should include transportation charges. Please quote Taxes separately in the format as per existing rates.
- 15. The payment shall be released within 15 days of satisfactory delivery of the materials to the satisfaction of the office.
- 16. Delivery period for all the items will be within 7 working days. The authority reserves the right to extend the delivery period on request with valid reason else following penalty clause shall be applicable.

- 17. Penalty Clause:
- a) 1% of the bill amount for delay in supplying of materials up to 15 days.
- b) 2% of the bill amount for delay in supplying of materials up to one month.
- c) 5% of the bill amount for delay in supplying of materials more than one month.

- 19. The Technical Bid will be opened on <u>11-01-2023</u>. The bidders or their authorized representative may also be present during the opening of the Technical Bid, if they desire so, at their own expenses. (Given at Annexure—A)
- 20. Financial/Price Bids (Given at Annexure—B) of only those bidders will be opened whose technical Bids (Given at Annexure—A) are found suitable by the committee appointed for the purpose. In exceptional situation, the committee may negotiate price with the qualified bidder quoting the lowest price before awarding the contract.

## 21. Pre - Qualification Criteria:

- a) The bidder must be a registered/authorized firm with GST registration clearly mentioning the scope of items authorized to supply from the registration authority.
- b) Trade License issued by the Khasi Hills Autonomous District should be valid for the financial year 2022-23.

### 22. Prices:

The Prices quoted should be inclusive of all taxes or duties, packing, forwarding, freight, insurance, delivery at destination site (Directorate of Sports and Youth Affairs, J.N. Stadium Polo, Shillong). The rates shall be firm and final. Nothing extra shall be paid on any account. Taxes shall be applicable/deducted as per Central/state rule.

## 23. Delivery:

The materials should be delivered within the period as specified in the purchase order unless otherwise prescribed. Any deviation in the material/item and the specifications from the accepted terms may liable to be rejected and the bidders need to supply all the goods in the specified form to the satisfaction/specifications specified in the order.
